Background

Indonesia is among the world's large emitters of greenhouse gases (GHG), even though the GHG contribution is within the forestry sector, due to high demand of fossil fuels and low energy efficiency in the industries.

Concurrently, Indonesia suffers already and will continue to suffer both socially and economically from the negative impacts of climate change, which leads to a considerable vulnerability in most important sectors of the Indonesian economy. Therefore, new climate strategies and instruments need to be implemented to reduce the GHG emissions and to adapt to the new environmental conditions.

Main approaches to mitigate and deal with climate change are to improve the policy framework conditions for climate protection and its adaption on national, provincial and local level, as well as to create models for efficient GHG emission reduction.

In order to find innovative and appropriate solutions to climate change problems, the German Government continues the successful collaboration with the Indonesian Government that has started in 1999.





PAKLIM

PAKLIM supports the Indonesian Government's planning and implementation of strategies for effective climate mitigation and adaptation to climate change.

This program encourages industrial enterprises to apply more resource and energy efficient processes by taking into account their potentials on cost savings and competitive advantages, as well as the positive effects on climate change.

Pilot projects with cities and medium and large industrial enterprises will be established to demonstrate the efficiency of applying climate friendly strategies. Therefore, financial mechanisms, such as Public Private Partnership, Clean Development Mechanism and Financial Cooperation are used to support.

PAKLIM is jointly implemented by the Ministry of Environment, selected sector ministries, local governments, and other agencies.

Main objective of PAKLIM program is to support Indonesian cities, industrial enterprises and the national government plan and implement new climate strategies for an effective climate mitigation and adaptation to climate change.

PAKLIM services are delivered through two program components; each providing advice, technical support and training specific to Indonesian issues.

1. National and Local Policy Advice

Improvement of the policy framework conditions on national and local level for the implementation of climate protection and adaptation measures.

- Creating economical and fiscal instruments
- Support mechanisms to use tools to implement strategies for climate protection and adaptation

2. Mitigation of Greenhouse Gases from Stationary Sources in Industries and Cities Provision of models on efficient reduction measures of GHG emissions from stationary sources for selected industry sectors and cities




 Promote and support cities to develop and implement an integrated climate strategy for climate change mitigation and adaptation
